

#### Granite City CEO Class of 2017

Every day and every year is different in CEO and this third year of our Granite City CEO program is no exception. Students are different, class speakers are different and business visits are different. Students are different at the end of the year than on the first day of CEO class in August. Students are transformed from being a typical high school student sitting in classrooms with a textbook and being graded on tests to young professionals acting and thinking differently, thinking like an entrepreneur and looking at the world in a different way.

This transformation occurs because of the level of support and commitment from our business community, our leaders, investors, CEO board members, mentors, visitors, and hosts. Every day students are inspired by different leaders and are given the opportunity to experience different examples of inspiration. We had the honor and privilege of 50 business visits in Granite City and the St. Louis region and listening and learning from 49 speakers in our CEO classroom.

One of our August speakers was Mrs. Ashley Swip, a Granite City High School physical education teacher. Students were inspired and moved by her story of her brother's battle with melanoma cancer at age 28. She formed a 501c3 nonprofit organization, 3 Little Birds 4 Life, to grant wishes to adult cancer patients. She learned through this experience there were no available resources to help adult cancer patients. The students were so impressed and had a true determination to make a difference and help the cause. They went through the proper channels and obtained District #9 School Board approval in October to start a chapter of 3 Little Birds 4 Life by creating the Warrior Flock. The Warrior Flock encourages healthy habits with an increased awareness in living healthier into adulthood and practicing an active lifestyle. Students contributed to the cause by collecting items and delivered gift bags to adult cancer patients at the Siteman Cancer Center in St. Louis. They also became part of the wish team and helped with granting wishes.

My wish is for our young adults to keep being inspired, solving problems and to continue looking at our community and the world in a different way. Developing our own young entrepreneurs is a vital investment in the growth and future of Granite City.

On behalf of my thirteen Granite City CEO board members, I sincerely appreciate and thank our business community, students and their parents, for making a difference in our community's future.

#### Class Information

Granite City CEO is one of fourty three programs encompassing participants from one high school, Granite City High School. The CEO class is a two semester business elective at Granite City High School for seniors. The seniors, along with their facilitator, meet for first and second hours off-campus every day from 8:00 to 9:30 a.m. Students then travel to the high school to attend their 3rd through 7th hour classes. This program allows students to participate in all school activities. Students complete an application for the CEO program at the beginning of the second semester of their junior year. The class is hosted by a different business every nine weeks and the students meet at the host business when the class is not on a business visit. I am very thankful for the speakers, business owners and to the CEO Board members that have helped make this happen. 
